

LIEN SALE RULES

1. Prior to entering all participants must sign-in, please print clearly:
 - Full name
 - Full address
 - Phone number
2. Proper identification is required.
3. Only cash bids are acceptable. **ALL BIDS ARE FINAL. SALES ARE "AS IS"**.
4. Any individual acting as an agent, either for a company or a private party, must be pre-approved by Ross Baker Towing, Inc.
5. All sales will be to the individual doing the bidding, unless they are registered as an agent for another party.
6. During the sale, participants will not be permitted to walk around in the yard. You must stay with the group and be 4 feet away from lien sale vehicles.
7. Vehicles for the sale may be viewed between 06:30am - 08:00am on lien sale day.
8. **NO STARTING OF VEHICLES OR OPENING DOORS IS PERMITTED.**
9. The lien sale will promptly start at 08:00am.
10. As a courtesy to the bidders, there will be no talking allowed during the bidding unless you are bidding on a vehicle.
11. No opening bid will be given by Ross Baker Towing, Inc. Ross Baker Towing, Inc. holds the right to bid on vehicles. Ross Baker Towing, Inc. will announce who will be bidding on behalf of a company or as an agent.
12. If any employee of Ross Baker Towing, Inc. will be attending the sale either as an agent or individual participant, an announcement will be made prior to the start of the sale.
13. No children will be admitted to the sale without prior approval of Ross Baker Towing, Inc.

14. Any employee of the City of Los Angeles is required to note that they are employed by the city when registering and shall notify a Ross Baker Towing, Inc. employee when a purchase has been made.
15. When bidding on a vehicle you must bid at a minimum of \$25.00 increments. If you are the highest bidder you must have proper governmental picture I.D. and the deposit amount with you at time of bidding.
16. A \$100.00 deposit will be required from the highest bidder, (unless the bid is over \$999.00, then the deposit required will be \$500.00) this deposit is a non-refundable deposit. The purchaser has until 12:00pm of the lien sale day to pay the balance on the vehicle. No vehicle will be held over. If the customer does not pay in full by 12:00pm it will be presumed that the customer does not want to purchase the vehicle and forfeit the deposit.
17. All lien sale vehicles must be removed from the lot by 5:00pm on the day of the sale, this does not apply to long lien vehicles. Any vehicle not picked up will be subject to additional storage charges.
18. No working of vehicles is permitted while on Ross Baker Towing, Inc. property.
19. All vehicles parked in the parking lot at time of closing will be impounded by another tow service.
20. Any vehicle sold according to California Civil Code Section 3071 which are called long lien vehicles or vehicle valued over \$4,000.00 have a ten (10) day acquisition period during which time the registered owner or legal owner hold the right to redeem the vehicle. During this period Ross Baker Towing, Inc. will hold the full amount of the bid as a deposit. If the vehicle is redeemed within the ten days, the deposit will be refunded in full. (The vehicle must be picked up at 2pm sharp on the 10th day by the buyer.)
21. Effective August 1, 1990 all lien sale vehicles will be subject to a 10% tax on the storage portion of the lien. The buyer is responsible for this tax.
22. You are responsible for back registration, smog and out of state transfers.
23. If a customer bids on a vehicle and does not choose to honor their bid, the following will happen:
 - The customer will be asked to leave the sale but can return the following week.
 - We will then ask the next highest bidder if they will honor their bid, if they don't want to honor their bid the vehicle will then go to the Ross Baker Towing, Inc. for its charges.
24. Any violation of the above rules will be cause for dismissal from the sale.
